This policy also operates within the statutory safeguarding framework set out in *Keeping Children Safe in Education (KCSIE) 2026*. KCSIE 2026 identifies *Working Together to Improve School Attendance (DfE, July 2026)* as statutory guidance and clarifies that persistent absence should always be considered a potential safeguarding concern. Attendance monitoring therefore forms part of the school's wider safeguarding systems and early-help processes.

The importance of school attendance

Improving attendance is everyone's business. The barriers to accessing education are wide and complex, both within and beyond the school gates, and are often specific to individual pupils and families. The foundation of securing good attendance is that school is a calm, orderly, safe, and supportive environment where all pupils want to be and are keen and ready to learn.

Some pupils find it harder than others to attend school and therefore at all stages of improving attendance, schools and partners should work with pupils and parents to remove any barriers to attendance by building strong and trusting relationships and working together to put the right support in place. Securing good attendance cannot therefore be seen in isolation - effective practices for improvement will involve close interaction with schools' efforts on curriculum, behaviour, bullying, special educational needs support, pastoral and mental health and wellbeing, and effective use of resources, including pupil premium. It cannot solely be the preserve of a single member of staff, or organisation, it must be a concerted effort across all teaching and non-teaching staff in school, the trust, the local governing body, the local authority, and other local partners.

In line with *KCSIE 2026*, all staff understand that patterns of absence, lateness or sudden changes in attendance may indicate wider safeguarding or welfare concerns. Such information should be shared promptly with the Designated Safeguarding Lead (DSL) and considered alongside other safeguarding records.

The law on school attendance and right to a full-time education

The law entitles every child of compulsory school age to a full-time education suitable to their age and any special educational need they may have. It is the legal responsibility of every parent to make sure their child receives that education either by attendance at a school or by education otherwise than at a school.

Where parents decide to have their child registered at school, they have an additional legal duty to ensure their child attends that school regularly. This means their child must attend every day that the school is open, except in a small number of allowable circumstances such as being too ill to attend or being given permission from the school for an absence in advance.

Working together to improve attendance

Successfully treating the root causes of absence and removing barriers to attendance requires schools and local partners to work collaboratively with families — and not against families. All partners should work together to remove barriers and improve attendance.

Attendance improvement is inseparable from safeguarding practice. *Keeping Children Safe in Education (KCSIE) 2026* emphasises that patterns of absence or sudden changes in attendance may highlight pupils who are at risk of harm, neglect or exploitation. Schools should therefore use attendance information as part of their wider safeguarding monitoring and decision-making processes.

Monitor

Rigorously use attendance data to identify patterns of poor attendance as soon as possible so all parties can work together to resolve them before they become entrenched.

Expect

Aspire to high standards of attendance from all pupils and parents and build a culture where all pupils can, and want to, be in school and ready to learn by prioritising attendance improvement across the school.

Listen & understand

When a pattern is spotted, discuss with pupils and parents to listen and understand barriers to attendance, and agree how all partners can work together to resolve them.

Facilitate support

Remove barriers in school and help pupils and parents to access the support they need to overcome the barriers outside of school. This might include an early help or whole family plan where absence is a symptom of wider issues.

Formalise support

Where absence persists and voluntary support is not working or engaged with, the school and partners should work together to explain the consequences clearly and ensure support is also in place to enable families to respond. Depending on the circumstances, this may include formalising support through an attendance contract or education supervision order.

Enforce

Where all other avenues have been exhausted and support is not working, or not being engaged with, enforce attendance through statutory intervention: a penalty notice in line with the National Framework or prosecution to protect the pupil's right to an education.

Expectations of schools

All schools have a continuing responsibility to proactively manage and improve attendance across their school community. Attendance is the essential foundation to positive outcomes for all pupils and is therefore seen as everyone's responsibility in school.

Schools will:

- Develop and maintain a whole school culture that promotes the benefits of high attendance
- Have a clear school attendance policy which all leaders, staff, pupils, and parents understand
- Accurately complete admission and attendance registers and have effective day to day processes in place to follow-up absence
- Regularly analyse attendance and absence data to identify pupils or cohorts that require support with their attendance and put effective strategies in place

- Build strong relationships with families, listen to and understand barriers to attendance and work with families to remove them
- Share information and work collaboratively with other schools in the area, local authorities and other partners when absence is at risk of becoming persistent or severe
- Be particularly mindful of pupils absent from school due to mental or physical ill health or their special educational needs and/or disabilities and provide them with additional support.
- Ensure attendance information is regularly reviewed by the Designated Safeguarding Lead (DSL) so that patterns of absence can inform safeguarding, early-help and multi-agency support as set out in *KCSIE 2026*

Expectations upon the trust boards and locally governing bodies

Improving attendance requires constant focus. Effective whole school approaches require regular ongoing support, guidance, and challenge. The expectation upon the Trust and local governing bodies is to:

- Recognise the importance of school attendance and promote it across the school's ethos and policies
- Ensure school leaders fulfil expectations and statutory duties
- Regularly review attendance data, discuss, and challenge trends, and help school leaders focus improvement efforts on the individual pupils or cohorts who need it most
- Ensure school staff receive adequate training on attendance
- Share effective practice on attendance management and improvement across schools

Expectations of local authorities

The local authority has a crucial role in supporting pupils to overcome barriers to good attendance and ensuring all children can access the full-time education to which they are entitled. Local authorities are facilitators of wider support needed by individual families and schools to overcome barriers in the short term. They are also strategic leaders that work across a geographical area to remove barriers in the longer term. The expectation upon the local authority is to:

- Rigorously track local attendance data to devise a strategic approach to attendance that prioritises the pupils, pupil cohorts and schools on which to provide support to, and focus its efforts to unblock area wide barriers to attendance
- Provide a School Attendance Support Team that offers the following:
 1. Communication & advice
 2. Targeting support meetings
 3. Multi-disciplinary support for families
 4. Legal intervention
- Monitor and improve the attendance of children with a social worker through their Virtual School Head
- Schools and local authorities must also ensure that alternative provision used for pupils with attendance or behavioural challenges meets safeguarding expectations. As clarified in *KCSIE 2026*, schools must obtain written confirmation from any alternative provider that all appropriate safeguarding checks and procedures are in place before commissioning placements.

Persistent and severe absence

Where absence escalates and pupils miss 10% or more of school, working alongside the local authority, schools will put additional targeted support in place to remove any barriers to attendance and re-engage these pupils. In doing so, schools should sensitively consider some of the reasons for absence and understand the importance of school as a place of safety and support for children who might be facing difficulties, rather than reaching immediately for punitive approaches.

Severely absent pupils are those that are missing 50% or more of school. Particular focus should be given by all schools and partners to prioritise these pupils for support.

Persistent or severe absence should be shared with the Designated Safeguarding Lead (DSL) and, where appropriate, with children's social care or the local authority early-help team, in accordance with *KCSIE 2026* and *Working Together to Improve School Attendance (2026)*.

Attendance legal intervention

As absence is so often a symptom of wider issues a family is facing, schools, the Trust and the local authority will work together with other local partners to understand the barriers to attendance and provide support. Where that is not successful, or is not engaged with, the law protects pupils' right to an education and provides a range of legal interventions to formalise attendance improvement efforts, and where all other avenues have been exhausted, enforce it through prosecuting parents. Attendance legal intervention can only be used for pupils of compulsory school age and decisions should be made on an individual case by case basis.

The full range of legal interventions are to be considered when making decisions on an individual case by case basis. These are:

- Attendance contract
- Education supervision orders
- Attendance prosecution
- Fixed penalty notices

Contents of the admissions register ('the school roll')

The school admission register, sometimes known as the 'the school roll', must be kept in accordance with regulation 8 of the School Attendance (Pupil Registration) (England) Regulations 2024.

It is vital that the admission register is kept up to date. Schools should encourage parents to inform them of any changes whenever they occur and ensure the admission register is amended as soon as possible. Changes could include pupils with a new address and/or school.

A pupil's name can only be deleted from the admission register for a reason set out in regulation 9 of the School Attendance (Pupil Registration) (England) Regulations 2024. A pupil's name must not be removed for any other reason and doing so would constitute off-rolling.

Contents of the attendance register

All schools must keep an attendance register in accordance with regulation 10 of the School Attendance (Pupil Registration) (England) Regulations 2024.

Schools must take the attendance register at the beginning of each morning session and once during each afternoon session. On each occasion the register is taken, the appropriate national attendance and absence code must be entered for every pupil. The codes are set out in regulation 10 of the School Attendance (Pupil Registration) (England) Regulations 2024.

The national attendance and absence codes are used to record and monitor attendance and absence in a consistent way and are used to collect statistics through the School Census system. This data helps schools and the Trust to gain a greater understanding of the level of, and the reason for, absence and the delivery of education.

Roles and responsibilities

Pupils arriving late to school

It can also be unsettling – both for the child and their classmates. • Any child arriving at school between 9.10am and 9.30am will be given a late mark (L). • If a child arrives at school after 9:30am, this will be recorded as an unauthorised absence (U). • School will look at child's overall attendance figures, when considering referring to the Local Authority for issuing of a fixed penalty notice. • Parents will receive a warning of a penalty notice for unauthorised leave. • Where the national threshold is met (10 unauthorised sessions in any rolling 10 school weeks), the school will refer the matter to the Local Authority, and a penalty notice will normally be issued in line with the National Framework
Medical Appointments
• To ensure medical absences are authorised, you must inform the school beforehand, ideally by obtaining a signed appointment card or letter from the clinic. While schools usually authorise medical absences, particularly hospital appointments, and generally do not require extensive medical evidence, they can ask for it if there are doubts about the legitimacy of the absence. The headteacher decides whether to authorise an absence, but their decision is based on the individual circumstances and must align with national guidance. Steps to Authorise Medical Absence • Inform the School: Contact the school as soon as possible to let them know your child will be absent. • Provide Evidence (If necessary): Obtain a stamped and signed appointment card, or a letter from the clinic or hospital, as proof of the appointment. • Keep the Absence Brief: Ensure your child only misses the minimum amount of school time necessary for the appointment. • Know the Attendance Codes: Schools use national codes to record absences; a medical appointment would be recorded as "C" (exceptional circumstances) if not illness, or "I" (illness) if the child is too sick to attend. Key Points for Parents • Headteacher's Discretion: The headteacher is the only one who can authorise absence. • Don't Miss Appointments: Schools are recommended to authorise absences related to medical conditions and should not penalise a child for unavoidable hospital appointments. • Avoid Unnecessary Absence: Medical appointments should be scheduled outside of school hours whenever possible. • Be Aware of Sanctions: Unauthorised absences can lead to parents facing fines or other legal penalties.
Performances, acting and sporting activities
If your child is involved in acting, modelling, performances, competitions or paid/professional sporting activities, please tell the school as early as possible if this will require time away from school. Taking part in such an activity does not automatically mean that absence from school will be authorised. Where a child performance licence, exemption or other formal approval is required, the relevant procedures must be followed and the school may ask to see supporting documentation before agreeing any absence. Parents should not assume that involvement with a theatre company, agency, sports club or similar organisation gives permission for a child to miss school. Requests will be considered individually, taking account of the relevant licensing arrangements, the evidence provided and the impact of the absence on the child's education. Where a licence application requires information or permission from the school, parents should give the school as much notice as possible so that the appropriate checks can be completed.
